

# Tribal Cultural Affairs: FY24 Tribal Arts Grant

## Program Background

This grant is a pilot project that offers funding to support Tribal communities as they expand, enhance, or create space for art and culture that is respectful and responsive to each community's needs.

#### Eligibility

Applicants must be a Washington State Federally-recognized Tribe. This is a non-competitive grant; all eligible applicants will receive an award pending staff review and board approval.

#### Timeline

The application was open from January 15, 2024 – February 28, 2024, at 5 p.m. Grant recipients will have until June 30, 2024 to spend their awarded funds.

#### Tribal Arts Grant Priorities

- Expand arts participation by ensuring that communities across the entire state of Washington have access to culturally relevant arts experiences.
- Support projects, programs, and services spanning a diversity of artistic disciplines and traditions.
- Foster equity and expand the creative economy by funding groups that have historically been excluded from government arts funding.

#### Funds will cover:

- Artist, teaching artist, and contractor fees
- Tribal museum enhancements
- Rent (equipment or space)
- Travel expenses for in-state artists or consultants
- Materials, supplies, software, and technology
- Administrative expenses, including printing costs, postage, and other administrative fees
- Fees for increasing access to programming such as closed captioning, translation services, interpreters, or consultant support on these efforts
- Support of Native/Indigenous artists for start-up funds (business license, website development, technology)

#### Process

A total of 20 eligible applications were submitted during the application period (January 15-February 28.) Staff reviewed applications to ensure organizations were eligible for the program.

The list of the 20 recommended eligible applications, and 0 declined eligible applications is included in this packet. Grant amounts were determined by Tribal project needs. Applications are listed by Tribal name and includes project, county(ies), request, and recommended grant amount.



## Projects

Projects include classes and materials for weaving, traditional regalia and garment making, beadwork, drum making, and carving. Several projects are commissioning murals and art installations from Tribal artists, for Tribal citizens to experience in health and community centers. Many Tribes will be using the funds for language programs and for some, the creation of culturally appropriate children's books. Almost every project will use the funds to support artists and cultural knowledge holders within the Tribal community.

## Recommendation

That the Board approve the recommendation for FY24 Tribal Arts Grant totaling \$522,720 as provided in the packet.

# Wellness, Arts, and the Military Vet Corps Rural Service Project Grant

## Overview

The Vet Corps Service Project Support Grant will provide a one time, up to \$3,000 grant for Vet Corps Members to provide arts-based service projects through their host sites and communities. These projects can include but are not limited to examples such as the following:

- Arts-based workshops
- Art Exhibition
- Creative Writing Workshops
- Community artmaking gatherings
- Dance and Movement Classes
- Group gatherings & performances
- Cardmaking events
- Music, performance, or arts-based professional development opportunities
- Media arts trainings or gatherings
- Storytelling Circles

For the purposes of this grant, an eligible "Vet Corps Member" is defined as an AmeriCorps Member serving through the Washington State Department of Veterans Affairs at different rural sites throughout Washington State. "Host Site" is defined as the organization that hosts a Vet Corps Member and will be the responsible party contracting with ArtsWA to service the approved project. Vet Corps Members serving urban sites may collaborate with rural host sites but are not eligible to apply through the host site they serve.

#### Funding amounts

- Grants up to \$3,000
- No funding match required

#### Eligibility:

- Washington-based Vet Corps Members are eligible to apply for the grant if they have the support and approval of their host site.
- If approved for a grant, ArtsWA will allocate funds to the host site on behalf of the Vet Corps member. The host site will administer project funds on behalf of the Vet Corps Member.
- A final report will be due no later than July 31, 2024 (Failure to submit a final report may jeopardize future funding possibilities).



Who is not eligible to apply?

- Individuals
- Sites and Organizations that are \*NOT\* Listed on the application form

### Recommendation
